<u>Clean Coasts & Cork County Council Cork Harbour Artwork Competition:</u> Terms & Conditions

- **1. Number of Entries:** The maximum amount of poster entries permitted per person or group is 1.
- **2. Number of Participants per group:** The maximum number of participants per group is 5 people.
- **3. Physical Poster Submissions Size:** If physical copies of posters are sent, they must be single-sided and A3 in size and posted to:

The Clean Coasts Programme, An Taisce EEU, 5a Swift's Alley, Francis St, Dublin 8, D08TN88

4. Digital Poster Submissions: Digital Poster Submissions must be sent in a PDF format. When uploading the PDF, it must be titled in the following format:

Entrants Name/Names_Title of Submission_Type of Submission_School Name_Date Submitted.pdf

Example: Mary Jones_Sunset at Dawn_ Poster_St Mary's Scndry Schl_5.2.22.pdf



If sent by email entries should be submitted to <u>cleancoasts@eeu.antaisce.org</u> with the email subject line as Cork Harbour Art Competition 2022 for all submissions.

If your poster file is too large to send via email you can send the video to us through WeTransfer.

5. Video Submissions: Videos should be produced in landscape orientation and last no longer than one minute. Videos should be uploaded in MP4 format (no larger than 250MB) and sent to our email address at cleancoasts@eeu.antaisce.org.

If your video file is too large to send via email you can send the video to us through WeTransfer.

Applicants should note that videos should not be in the public realm prior to submission. Any links shared should be private, password protected or marked as an unlisted video on video sharing websites. If you are including music in your video the music must be copyright free so that if chosen your video can be put online on websites such as YouTube.

When uploading and saving your video it must be titled in the following format:

Entrants Name/Group Name_Title of Submission_Type of Submission_School Name_Date Submitted.mp4

Example: Mary Jones_Sunset at Dawn_ Video_St Mary's Scndry Schl_5.2.22.mp4

- **6. Video and Poster Content:** While we encourage creativity, humour, and expression within the applicant's submissions anything that An Taisce deems disrespectful, explicit, or inappropriate will not be considered so please be respectful with your content.
- **7. Relevant Information:** All competition entries must include the following information via email to cleancoasts@eeu.antaisce.org and label the email subject line as Cork Harbour Art Competition 2022 for all submissions.
 - First Name;
 - Last Name;
 - Number of people in group (if applicable);
 - Age(s);
 - Category applying to;
 - School (if applicable);
 - Address,
 - Parent/Guardian/Teacher's Name;
 - Written permission from a Parent/ Guardian if you are under 18
 - **Contact Number:** If you are under 18 this must be the contact of a parent, teacher or guardian;
 - **Email:** If you are under 18 this must be the contact of a parent, teacher, or guardian,



- School's Details (if applicable): Entries should be accompanied by contact details for the relevant teacher (name, phone number and email address) for correspondence purposes.
- **Postal Address:** Entries should be submitted by post to the following address: The Clean Coasts Programme, An Taisce EEU, 5a Swift's Alley, Francis St, Dublin 8, D08TN88.
- Email Address: If sent by email entries should be submitted to <u>cleancoasts@eeu.antaisce.org</u> with the email subject line as Cork Harbour Art Competition 2022 for all submissions.
- 8. **Closing Date:** Entries must be received at the above address by 4:00pm the 29th April 2022.
- 9. **Notification:** Winners will be notified within 30 days of the close of the competition by either post/telephone/email.
- **10. Judging:** An independent panel of judges will select the winning entries. The judges' decision is final. No correspondence relating to the competition will be entered. An Taisce cannot be held responsible for entries that do not arrive due to technical issues. Shortlisted entrants will also be asked to provide an extended caption.
- **11. Prizes:** €500 will be given to the winning school. Additional Individuals/groups within the winning entry will receive a €150 One4all voucher.

Additional prizes will be awarded to second and third place.

- 12. Returns: Clean Coasts is unable to return any entries to schools.
- **13. Publicity:** Ownership will remain with the entrant/entrants although winning images will be used and displayed by Clean Coasts in conjunction with Cork County Council and Bus Éireann and for additional promotional purposes. These may include brochures or printed produce relating to the competition, the organisers' websites or websites connected to the competition and work of An Taisce.

Winners may be asked to take part in competition publicity including being photographed by the media.

- **14.** Eligibility: The competition is open to young people aged 11-19 who are residing in Cork.
- **15.** Entry to the competition constitutes full and unconditional acceptance of these Terms & Conditions.
